To review the meeting structure for Aldenham Parish Council

AGENDA item 5 Annual Meeting of the Council 24th May 2021

Background

Aldenham Parish Council (APC) has a council and committee structure that has been in place (in several guises) for many years. Currently there are four committees for, Finance, Planning, Open Spaces and Community Development.

The government legislation allowing councils and their committees to meet using zoom, has now ended so face to face meetings are compulsory. Members have stated that video conferencing was very convenient and an efficient method of holding meetings and making decisions. Working party meetings can still be held via zoom as the Local Govt Act 1972 does not cover such meetings, as they are more informative and have no decision-making powers.

Currently APC have active working parties for 'Around Radlett, 100-year celebrations, Phil Rec Improvement project, some of which include non-councillors which brings a different dynamic to the proceedings, as also was seen with the Radlett Neighbourhood Plan.

A review of the agendas for, especially the Open Spaces and Community Development Committee would question why these items are brought to committee when they could be either discussed by a working party over a few meetings or delegated to the Council Manager. Such examples as the Winter Lights, which, now they are in place will last for five years (why discuss this every year), or whether someone can have a polytunnel on their allotment plot (an officer could decide this).

Recommendations

That the Open Spaces and Community Development Committee are disbanded with either working parties set up or decisions delegated to the Council Manager.

Reasons for recommendation

By moving to working parties where necessary, these will report to full council and so all councillors are made in the decision rather than delegated to a committee and other councillors wanting to have been involved in the decision process.

The ability to include outside experts on working parties for specific projects as was noticed in the Radlett Neighbourhood Plan. An analysis of the agenda items on both these committees for 2020/21 is shown below and alternatives are shown.

Community Development Committee

- New website Annual review by council, anything noticed during the year e-mail Council Manager who will rectify.
- Events working party to discuss ideas which will then be sent to contractor to prepare budget, officer then works with contractor rest of the time. This is approach used for 100yr celebration.
- Radlett Youth Council reports now to Full Council
- Around Radlett publication keep as working party
- Grants for community move to Finance & General Purposes Committee to consider alongside CiL grants.

Open Spaces Committee

- Allotments move to working party, possibly include an allotment holder who could be asked to be part of the allotment policy review as they will know if a proposal would work or not. Officer decides if allotment holder can have a structure such as polytunnel, only if refused and allotment holder appeals will it come to full council.
- Tree works Officer receives annual report puts out to tender (as is current practice) brings report to Full Council to appoint contractor for work.
- Green Flag, Fir Spring & Scrubbitts Wood Management Plans Officer deals with work as per the plan, and this is included in annual budget submission.

The Council Manager will report all decisions made by him at the meeting so again a level of scrutiny for the council not available currently.

Alternative options

Retain the structure as it is. The full council meetings may be longer, councillors will be encouraged to ask questions on papers circulated before the meeting if it is for clarification.

Financial Implications

There will be a saving in officer time attending evening meetings which is then taken as 'Time off in Lieu' (TOIL) or overtime payments.

Risk Management Implications

That officers take decisions that should be scrutinised by Full Council. There is a safeguard that all decisions will be reported by Council Manager, so they can be questioned, at or before the meeting on an item.

Members are asked to consider this report.
